They are responding to the Lakewood calls due to their limited volunteers. During the Long Branch Fire, nine fire departments responded. They decided to let the fire burn itself out to reduce any risk of firefighters being injured in a fall or the cold. Oconto County I Am Responding system is still not working right and will probably continue like that until the system gets their upgrade.

Friends of Townsend Fire – Wanda Laste said there will be a spring cash raffle, drawing on March 8th, daylight savings. The members voted to donate the Smart TV to the Town of Townsend. This is located in the new meeting room, and no double will be a big asset to many who use the room. February 15 is the next meeting.

Lakes Country Library – Kathleen Marsh said the library stayed open during the cold snap and several people used it as a warming shelter. The doner tree & plaques are in place and look great. April 29 will be the annual banquet at the McCauslin Golf Course.

NOCCO – Zeller said that our NOCCO officer, Andy Dryja, has resigned to take a job with the DNR. DeMoulin and Evans attended a 7-towns meeting where Sheriff Skarban said the towns will not have to pay for a NOCCO officer in 2025. He is working with the state to get the same law enforcement services we had with the NOCCO. Nick School is a detective located full time at the Riverview location and an additional officer will be coming up.
